ABOUT US



Gözen, has started its operations under the name "Gözen Air Services" as an aviation service provider, is founded by M. Mekin Gozen and M. Mete Bozyiğit in 1979. In 1997, Gözen started providing security services for the Aviation Industry at Istanbul Ataturk Airport, after having C Group license from the Ministry of Transportation, State Airports Administration (act number 2920).

In 2004, when the law nr. 5188 concerning Private Security Services came into effect, Gözen has restructured as a private company. In 2005, Gözen/Aviation Security Department obtained the Private Security Operating Company license from the Ministry of Interior and continued its activities under the name "Gözen Security Services". Since 2005, the company has diversified its security services and started providing security to the Maritime Industry, which has similar features with Aviation Industry.

In 2000s', growing terrorist acts, necessitated revaluation of the security measures and requirements regarding sea transportation. In 2004, International Maritime Organization (IMO), which Turkey is a member of, approved to make some additions to the criterion determined with Safety of Life at Sea- SOLAS 74 agreement dated 1974, and the law called International Ship and Port Facilities Safety (ISPS) Code enacted.

In the ports graduated, according to the security levels, consistent with the international standards; the authorized ship owners who will realize the operations, may request to make changes on the degree and may demand additional security services when necessary. In such cases, Gözen Maritime Security, that has completed its structuring according to the law numbered 5188, provides the necessiated service accordingly.

Gözen provides security to all passenger ships including high-speed cruise ships, all cargo vessels including high-speed boats of 500 GRT and above and mobile sea drilling units, according to the IMO standards and ISPS Code provisions.

Gözen Maritime Security works with an innovative understanding that follows all improvements related to ship security in order to provide the most qualified service to its customers and to enable them to realize their work flow in a secure manner. Gözen Maritime Security evaluates the possible threats against its customers, holds risk analysis studies, provides the most appropriate guarding and security services according to the risk analysis studies. Gözen Project Group, considering the national and international needs of the security industry, develops the most updated technological systems which can be integrated to the operations.

Main policy of the company is to protect ships and passengers from terrorism in accordance with national and international programmes and to design and apply measures that will develop security. Gözen performs unique security solutions with qualified and experienced personnel which ease the operations of customers and add value to their services.

Test and Evaluation

Security Audits

Considering the possible illegal attempts, Gözen determines the vulnerabilities, positions the right staff at the right locations and evaluates the efficiency of each personnel by regular audits.

Assigned Security personnel is audited by qualified auditors considering the compliance with the security standards and applications determined by National and International authorities with our daily operations, and their compatibility to standards of Gözen.

Security Tests (Drill System)

Gözen Security practices are realized in coordination with Ship Security Officers (SSO), Port Facilities Security Officer (PFSO) and the Police, and they are executed as part of security auditing. All the results are kept as confidential and provided to customers upon request.

Guarding, Searching & Security Services for Cruises, Private Yatch & Ships

Gözen performs and records pre-expedition ship searching activities, provides additional security services in accordance with the international IMO standards and the requirements of ISPS Code, depending on the approved ship security plans for the operations realized in ports open for international expeditions.

Our professional security teams determine the dangers, make risk evaluations and minimize the possible threats against ships, luggage, catering materials, stored food, cargo, passenger and the crew. Besides, they provide security of the ship on port and prevent unauthorized persons from boarding the ship.





Passenger & Crew Travel Documents Sufficiency Control

Recently, many countries have created obligations for ship owners in their laws. According to these laws, ship owner companies and operator companies that carry the passengers or crew travelling with insufficient documents (the passenger or crew that does not have a proper passport or valid travel documents in order to enter the country) when detected, have to pay huge penalties to immigration office administrations of the related countries. Besides, if those passengers are not allowed to travel with insufficient travel documents, their staying costs and medical costs and similar expenses of the passengers shall be covered by the maritime company.

Gözen Maritime Security's "Travel Document Sufficiency Control" service proved its effectiveness and prevented its customers from paying penalties generated due to document insufficiencies.

Gözen Maritime Security controls the Landing Cards and Company Identity Cards of the passengers and crew of the contracted maritime companies, in accordance with the security programmes defined by ISPS Code requirements (approved ship security plans) and the security programmes defined by that Company's Security Officer (CSO) considering their operational units that are formed according to the law numbered 5188. Moreover, the personnel that provides logistic support on port and the ones that are authorized to embark on the ship by the operator company, are also controlled by Gözen.

Luaggage, Cargo & Catering Materials Security Control

Gözen has the experience and capacity to integrate proper conventional X-RAY, ETD (Explosive Trace Detector), EDS (Explosive Detection System) devices into operations (for luggage, cargo and catering materials screening) with competent operators for preventing risks and dangers that may occur during the cruising. Moreover, well-trained K9 dogs that are sensitive to explosives are used for screening.

According to the operational needs of the contracted company, the most useful security personnel and operators will be selected and the most proper devices would be integrated into the operations. Computer-aided simulator programs are used to train our operators. Besides, they are used to control each operator's performance on daily basis, before they take active position in the operations.







Computer-Aided Passenger & Crew Security Screening Systems Before Expedition

International terror threat, increase in international travels and increase in the need of efficient border control brings forth the need to examine the universal systems infrastructure. Besides the need to check the identity and travel documents with more developed technical systems and competent personnel to use these systems. Gözen, adopted to these changes, developed the below systems, software, hardware and adopted them to its operations.

Gözen Security Information Technologies, founded in 1996 under Gözen Air Services, has been allocated to satisfy the existing and future needs of our customers. High-technology products, integrated systems and applications are developed to make contribution to the homeland security, help increasing the efficiency of security operations in various fields; public transportation security that includes registered passenger programmes (airways, maritime etc.); border control/immigration status etc. All systems, design of podiums, software and hardware are patented by Turkish Patent Institute.

WSO (Watchlist Secured Operation/Advanced Screening System)

WSO system that provides passenger-screening enables to provide cruising manifest lists including reservation information of the passenger, who will be accepted on board and crew information on digital platform in accordance with the standards agreed by the customer company, and to control them automatically on digital platform.

This system is used as an important rule engine that enables the detection of the risky persons who are notified to the ship agencies or companies for ship voyages from Turkey to the destination points (Cruise line or cargo-passenger ships). We have a large database due to our national and international network we have formed within our own structure. This system enables to handle pre-departure security checks in detail and helps to improve the operation efficiency.


APIS (Advanced Passenger Information System) Solutions

APIS is the transaction of collecting Crew and Passenger Personal Information and expedition details on computer, in accordance with the defined criteria of MCL, FCM, APIS PAX LISTs according to US Agreement, which is signed by US MOU and TSA and between American Homeland Security- CBP: Customs and Border Protection - Customs Office and the ships in accordance with the criteria defined and sending it to the designated address within the determined period.

PIDS (Passport Id & Document Verification System)

PIDS "Passport and ID/Document Verification System" has been structured in order to support business unit, personal identification and increase their accuracy, to develop the global infrastructure of originality and efficiency and to find solutions. PIDS gives us the opportunity to collect, check, record and prove the accuracy of personal identity information of ticket holder. For instance; Automatically read MRZ of the passports, MRZ of visas, MRZ of the identity documents etc.






K9 Security Operations
